Guardian Tracking

- **As we continue to improve the operations of this system we are exploring the possibility of eliminating yearly evaluations and use this system as a on going performance evaluating system.**

Power DMS

- **7th year of the Sheriff Office using a paperless system for documentation and communication.**
- **2,857 documents**
- **23,742 recorded signatures in 2017 (168,148 total)**
- **23 employee training sessions includes 7 tests completed for all employees for a total of 1147 tests completed to date**
- **114.8 Trees saved = 1,913 reams of paper = 956,609 sheets**
- **\$62,964.00 total savings in paper and printing**
- **Instant electronic viewing and response for records**

Internal Affairs

- **26 Case Records - 36 complaints**
- **3.7% decrease in case records & 0% increase in complaints**
- **36 complaints = 7 sworn LE Division – 0 complaints against civilian employees – 29 complaints against correction officers**

- **22 (61%) generated internally (supervisors or other members)**
- **14 (39%) complaints from citizens = 1 complaints from 1 members of the public, 13 complaints generated by 7 different inmates**

- **3 Use of Force = 3 exonerated**
- **2 Improper Search = 2 exonerated**
- **25 Other Rule Violations = 16 sustained, 3 exonerated, 6 not sustained**
- **1 Differential Treatment = 1 not sustained**
- **1 Domestic Violence = 1 not sustained**
- **1 Other criminal complaint = 1 sustained**
